

Home Study: Text book complete, exit exam and other grade specific activities are required.

Respect: Students are expected to fully cooperate with the teachers, staff, and each other at all times. No disruptions during class or any other activities will be tolerated.

Dress Code: Students are required to dress per Lafayette Parish School Board policy, no exceptions. *St. Anne T- shirts can be substituted for school shirts.*

Attendance: Please make every effort to get your child to class regularly and on time. Drop off time is 10 minutes prior to class start time.

Summer Program - No time missed is allowed. Students must be present every day, on time, until dismissal. Any student missing time will be transferred to Home Study.

Other Religion Programs - If a student is absent and/or tardy two (2) times per session/semester, the student will be transferred to Home Study for session completion.

No Cell Phones or Electronics: Students are not allowed to have cell phones or electronics in their possession while participating in any of our religious programs.

Discipline Policy for Respect, Dress Code, Cell Phone and Electronics:

1st Offense – The student will be removed from the classroom and picked up by the parent/guardian and/or transferred to our Home Study Program dependant on offense.

2nd Offense – The student will be removed from the classroom and picked up by the parent/guardian. The student will be transferred to our Home Study Program.

Zero Tolerance Drug/Alcohol Policy: Any student caught with any type of drug, medication, or alcohol in their possession will be automatically expelled from the program.

Diocesan Safe Environment Program: In the pastoral effort to respond to a heightened need for the protection of our children, the Diocese of Lafayette has developed “A Safe Environment for the Protection of Children and Young People” program. As part of this program, all children in our Religious Education (PSR) Programs will be participating in an education session relating to child abuse and prevention. By registering your child in our religion program parents are automatically giving consent for their child to take part in this safe environment session.

Sacramental Programs: Sacrament students must be up to date in their religious education. Participation in mandatory parent meetings, parent-student retreats, as well as additional fees, etc. is required.
